The RSM-Ex 01* is an intrinsically safe remote speaker microphone. The connection to the smartphone or further sources is realized with cable. The integrated loudspeaker is very powerful and allows clear communication even inside very harsh and noisy industry areas. It is a hand held device. The mounting on the user via belt clip is also possible. Power is supplied by a Li-ion battery, which is permanently installed in the device. Charging must take place outside the hazardous locations. Optionally, approved headsets can still be used for this device.

- It must be ensured that the maximum input voltage (U_m) for the device from the charger between the lines is 6V.
- The ambient temperature during the charging shall be in the range from 0 $^{\circ}$ C to +45 $^{\circ}$ C.
- Only those accessories approved by the manufacturer may be used.
